

## Dear Parent /Caregiver,

Enclosed please find documents relating to the Student Resource Scheme. These forms are standardised throughout state schooling and are explained below. If we already have your form from the enrolment process it is not attached and the following is for your information only.

### PARTICIPATION AGREEMENT FORM

This is where you decide whether or not you wish to participate in the scheme. If you have previously opted in to the SRS your participation is assumed for the remainder of your child's enrolment, unless you inform the College otherwise by completing a new participation agreement form.

Points for your attention:

- **15.** Parents who choose **not** to participate in the SRS are responsible for providing their student with all items that would otherwise be provided to the student by the SRS to enable their student to engage with the curriculum.
- **18.** As the SRS operates for the benefit of participating parents and is funded from participation fees, SRS resources will not be issued to students whose parents choose not to participate in the SRS.
